1. There is an argument in your office about classification of a 50 year old necklace. The chain and heart pendant of the necklace are made of zinc metal, with the pendant having a thin lining of gold constituting 1% of the product. One office mate is sticking to his position that it should be classified as a gold necklace, heading 7113. The other is taking a position that it is an antique which should be classified in Chapter 97.

<u>Give them the correct tariff</u> with convincing reasons from the customs tariff as to why the necklace cannot be classified as an article of gold nor can it be classified as an antique.

- **4.** Safeguard security imported armoured steel safes through Plumtree. The doors to the safes will be fixed to the frames in Zimbabwe. The safes are imported on steel wheeled trolleys for easy moving. The trolleys have to be sent back to Botswana. The safes are missing the keys for security reasons. The keys were imported separately through Bulawayo airport by airfreight. Give the tariff classifications for the safes and keys. Support your answer with good reasons from the customs tariff.

For the trolleys explain if they can be classified under safes. Do not give the tariff for the trolleys.
