**SECTION B: Classification with Reasons (Answer this section on a separate piece of paper)** 

For each of the following imported goods justify your classification with reasons from the Customs Tariff.



- An importer sends you literature of road construction equipment and spares that he intends to import and wants to be advised of the correct tariff. The equipment is capable of breaking/loosening earth, scooping earth and loading it into trucks. The spares comprise of steel helical spring and toothed Chain sprocket as shown in picture above. The first clearing Agent he consulted gave him the following tariffs:
  - i. 8704.1000 for the equipment
  - ii. 8708.7010 for the spares.

Find the correct tariffs for the three items of equipment that the importer has consulted you on. Write convincing reasons to the first Agent to show him that the equipment cannot be classified in section XVII and why they should be classified the tariffs that you have suggested. (20 marks)

- 2. Success abattoirs and tanners have received an order for the export of hides and skins. The order comprises of :
  - i. 2 tonnes raw ostrich skins with their feathers on, salted (to prevent them from decaying) but not further worked
  - ii. 2 tonnes of tanned ostrich skins with their feathers on, the feathers of which have been cut and combed.
  - iii. 5 tonnes raw, fresh and salted cattle hides with their hairs on, weight per skin (14 -16 kgs)

Success have consulted a Clearing Agent who has advised them to clear the whole consignment under the tariff for composition leather 4115.1000.

Your Supervisor has put a note on the letter of enquiry which reads "Write Agent X to convince him that the goods covered by the enquiry should be classified in Chapters 5, 41 and 67".

Find the correct tariffs for the three hides and skins. Write convincing reasons to the first Agent to show him that the consignment cannot be classified in his suggested tariff (16 marks)
