Question One

A farmer imports 50 bags of Lucerne grass seed. He feeds it to his cattle which will then spread the seed through their dung on his pasture land. A clearing agent has classified the seed under tariff 0604.9000 (9 marks)

Question Two

Classify a non-runner Mercedes Benz haulage truck, designed to pull semi-trailers coupled to a fifth wheel. The truck was bought missing car batteries and rear view mirrors which were stolen at point of loading. The truck is designed to run on diesel only. The engine on the truck is 6500cc. The importer has brought a second hand engine to fit on to the non-runner truck rather than try to fix the broken down engine. The replacement diesel engine is 7500cc. The truck and replacement engine were classified under tariff 8705.9090 as truck and part. (14 marks)
