 - New woven handkerchiefs made from 100% cotton measuring 63cm x 24cm 6213.2000

Your fellow workmate has classified the items in the Tariffs given above. You are sure all the suggested tariffs are wrong. Give the correct tariff classifications for the 3 items with your valid reasons. (17 marks)

 - Small threaded screws for spectacle frames

- Refractive glass spectacle lenses for correction of defective vision. Cant be classified under Chapter 90 because of Note 1(e) to Ch 90 (1); correct tariff is 7015.1000 (3)
 TOH and TOSH (1)
- Small threaded screws for spectacle frames Parts of general use Note 2 to XV (2);
 excluded from Chapter 90 by note 1(f) to Chapter 90 (1) 7318.1500 (3) TOH and
 TOSH (1)
- 20. A fellow student is struggling with the classification of dried fish not fit for human consumption. He insists that they fit under heading 0305. Give the correct tariff for these dried fish and justify why they should not be classified under heading 03.05. (5 marks)
